A. FSC COC & FM TRADEMARK LICENSE AGREEMENT (TLA)

This part of the form shall be used by the front office admin to request the launching of a digital FSC Trademark License Agreement in the FSC Database (Salesforce). The SGS Delivering Affiliate needs to complete and submit this form once the client has accepted the proposal, and before the audit takes place.

The completed form shall be sent to the person who is responsible for entering the client information in the FSC Database:

- For COC-Affiliates under the GBS to the GBS,
- For COC-Affiliates with own FSC-Database-Management to the own Database-Manager,
- For all other COC-Affiliates to Marinda van Zyl,
- For FM to Marinda van Zyl.

Once this information is entered and the launch of the digital TLA triggered, FSC will send an email to the client to create a profile on FSC Connect, in which they can digitally sign the TLA.
